

Advertising Terms and conditions

No Booking Agents

Accurate Information

Updates

Change of ownership

Annual Renewal

Approximately 2 weeks prior to your advertisement expiring you will be sent an e-mail advising that your advertisement is due for renewal. You may then cancel or renew the advertisement.
